<sup>\*\*</sup> Staff believes the Liquid Blended Phosphate bid submitted by Hawkins (\$43.10/cwt delivered), although the lowest, is not the best bid in meeting the City's needs. The Liquid Blended Phosphate bid by Bonded Chemicals (second lowest bidder with a bid of \$43.30/cwt delivered) contains 19% more of the active ingredient (phosphate) by weight. Given that more of Hawkins' product would be needed to get the same results as the Bonded Chemicals product, staff recommends that the Liquid Blended Phosphate be awarded to Bonded Chemicals as lowest and best bidder.
