MINUTES CHARTER REVIEW COMMISSION

City Council Chambers, March 19, 2020, 7:00 p.m.

- 1. Members of the Charter Review Commission met on March 19, 2020 with members John Bokros, LaVonne Bailey, Megan Reamsnyder, Dennis Blair, Larry Jenkins, Mary Johnston, Clerk of Council, Thomas Schmitt, Assistant Director of Law, and Assistant Prosecutor Lauren Swihart present. Also present was Jessica Hilts.
- 2. The Minutes for the February 25, 2020 meeting were previously provided to members.

Ms. Reamsnyder moved, Ms. Bailey seconded to approve the Minutes as provided.

The Minutes were approved by acclamation.

3. **PUBLIC COMMENT**

None.

4. <u>REVIEW OF CHARTER ARTICLES FOR ISSUES OF CONSIDERATION OR</u> ADDITIONAL DISCUSSION

Article III, Council

Section 1, Number and Term

Discussion was held on this section and the issue is moving the term start date to a later date that would match with the Organizational Meeting. The Commission agreed to recommend a change/revision.

Section 2. Qualifications

Consider allowing for appointment to intergovernmental cooperative entities (i.e. COTA) ("compatibility" and Council appointment/approval.

Section 3. Organization

Consider moving the Organizational Meeting to something other than "December 1" (i.e. "first regular meeting of December or January).

Section 7. Vacancies.

To consider whether to require in writing/electronically transmitted to the Clerk of Council with original signature delivered to the Clerk of Council.

Section 9. Special Meetings of Council

To consider electronic notice to Councilmembers and revise the requirement to "post".

Section 10. Clerk of Council

To consider deleting last two sentences/revising to allow for a Deputy Clerk to act and exercise same powers and duties.

Section 11. Salaries, Compensation & Bonds

To consider pay increase for officers to be provided when officer term changes but council set term does not.

Section 13. Legislative Procedure

Consider clarification that three readings is only necessary if the Resolution is of a general or permanent nature and that "property" is limited to "real property". Consider clarifying to avoid large statutes for minor language. Consider deleting the requirement to maintain three copies and allow for electronic retention/inspection. Consider allowing for automatic updates without Council action. Consider deleting the requirement to post in three public places in lieu of electronic publication/availability.

Section 14. Effective Dates of Ordinances and Resolutions

Consider allowing Resolutions to take effect in a shorter time frame than Ordinances.

Section 16. Relation of Council to City Manager

Consider adding an "employee protection and prohibition" section to prohibit candidates for elected office from seeking staff "endorsements" or prohibiting staff from using the influence of their office (express or implied) to solicit votes. It was felt this could be part of the Personnel Code.

Article IV. City Manager

Section 1. Appointment, Removal and Qualifications

Delete has having been superseded by state law (R.C. 9.481 adopted in 2006 Residency requirement). Consider referencing educational attainment, experience - not recommended by Commission.

Section 2. Powers and Duties

Consider including a requirement for the "Capital Improvement Plan".

Section 3. Assistant City Manager

Delete as having been superseded by state law (R.C. 9.481, adopted in 2006) (Residency requirement).

Section 4. Vacancy, Absence or Incapacity

Consider naming another department head or position. Consider allowing Council action by motion/resolution (something quicker than three readings/time frame.

Article V. Administrative Departments

Section 1. General Provisions

Consider realigning to be consistent with practice of department heads. Consider elevating Director of Planning and Development to a mandatory department. Consider one general "default" position that City Manager shall serve as Director and may appoint such deputy

directors.

Section 4. Director of Public Safety

City Manager shall serve as Director and may appoint such Deputy Directors.

Section 6. Director of Public Utilities

City Manager shall serve as Director and may appoint such Deputy Directors.

Article VII. Planning Commission

Section 1, Membership and Organization

Consider term limits. Consider allowing for appointment of alternates.

Article VIII. Fiscal Matters

Section 2. Fiscal Matters

Consider adding the Capital Improvement Plan to the list of required reports.

Article IX, Elections

Section 1. Time of Elections

Consider strengthening requirements for nonpartisan elections.

Article X. Initiative, Referendum and Recall

Section 1. Initiative and Referendum

Match state law (require petition to identify name(s) of candidates to fill recalled vacancy, and if not recalled, allow repayment of election expenses.

Article XI. General

Section 6. Vacancy in Board or Commission

Consider making for all boards and commissions.

Various

Review voting counts (Charter uses "of the members elected to Council" and "of Council" – prefer the second phrase. Review "appointment" of Officers (Charter uses "choose," "elect" and "select" "at various places.

5. REVIEW OF PUBLIC COMMENTS RECEIVED

The Commission reviewed the public comments received which totaled four. The Commission will discuss the term limits for boards and commissions and nonpartisan statement. The Commission will not discuss Council Chairs serve in the same capacity as Mayor and eligibility for appointment to Planning Commission.
