



## Utility Rates - March 2024

### ELECTRIC SERVICE

#### Residential Service

This service is available for domestic residential service to consumers supplied through the City's existing secondary distribution facilities. The type of service is alternating current, 60 hertz delivered at a nominal secondary voltage of 120/240 volts, single phase.

- The **Power Supply Cost Adjustment (PSCA) Charge** is applied to all kilowatt hours sold. The PSCA is calculated monthly to reflect changes in wholesale power supply costs.



## **WATER SERVICE**

---

For each 100 cubic feet (ccf) or 748 gallons of water used per month, or in a similar period, the following rates apply:

Minimum Charges	\$9.80 per month (includes first 2 ccf)
Next 13 ccf	\$5.32 per ccf
Next 85 ccf	\$4.37 per ccf
All above 100 ccf	\$3.02 per ccf

This minimum charge includes the first 200 cubic feet of water. Each billing unit is equal to one ccf.

7 Ccf (hundred cubic ft.)	Minimum charge	=	\$ 9.80
	+ 5 ccf @ \$5.32	=	\$ 26.60
	Water Charges	=	<b>\$ 36.40</b>

16 Ccf (hundred cubic ft.)	Minimum Charge	=	\$ 9.80
	+ 13 ccf @ \$5.32	=	\$ 69.16
	+ 1 ccf @ \$4.37	=	\$ 4.37
	Water Charges	=	<b>\$ 83.33</b>

## **SEWER SERVICE**

---

The following rates apply to sanitary sewer service, with usage based upon the metered consumption of water:

Minimum Charges	\$23.46 per month (includes first 2 ccf)
Over 2 ccf	\$ 7.10 per ccf

Each billing unit is equal to one ccf (hundred cubic ft).

Sample Calculation:	7 ccf (hundred cubic ft.)	Minimum Charge	=	\$23.46

### **SEWER DEDUCT METER CHARGE**

---

For customers who have an auxiliary sewer deduct meter, a monthly fee of **\$2.00** per meter is charged to recover administrative costs associated with the meter.

### **RESIDENTIAL REFUSE SERVICE**

---

The owner, occupant or tenant of a residential premise will be billed a monthly service charge for the collection and disposal of household trash, yard waste and recyclable items. This fee is **\$26.50** per month.

Senior residents who are the head of the household and are 60 years of age or older can apply for a monthly refuse discount of \$2.29. The monthly refuse rate for these customers will be **\$24.21** per month. To apply for the discount, seniors should visit the Utility Billing Department at 64 East Walnut Street and will be required to show proof of age identification to receive the discount. Upon request, a Westerville staff member can visit homebound residents to verify their age identification at their residence if they are unable to apply in person.
